4.A.4(a) Resolution 527: City Electronic Fund Transfer (EFT) Policy

BACKGROUND: The Washington State Auditor's Office (SAO) has requested that the City have a written policy on their Electronic Fund Transfer procedures. The proposed policy is simply the procedure currently used and approved by the SAO.

ACTION REQUESTED: Approve Resolution 527.

4.A.4(b) Ordinance 1081: Repeal of Medical Lake Municipal Code Section 2.24.035 (Fire Equipment Reserve Fund); First Reading

BACKGROUND: The City was annexed into Spokane County Fire District 3 in August of 2019 and no longer has a need or use for the Fire Equipment Reserve Fund. The presented Ordinance will repeal the fund with the contents of the fund remaining in the General Fund.

ACTION REQUESTED: Call for the First Reading of Ordinance 1081.

4.A.4(c) Ordinance 1082: Repeal of Medical Lake Municipal Code Section 2.24.500 (Treasurer's Suspense Fund); First Reading

BACKGROUND: The Treasurer's Suspense Fund was originally a fund, separate from the General Fund, used to receipt in and pay from deposits collected for various items (Special Event Permits, Park Reservations, etc.). The SAO now requires that refundable deposits be treated as General Fund revenues and expenses and therefore the Treasurer's Suspense Fund is no longer needed.

ACTION REQUESTED: Call for the first reading of Ordinance 1082.

4.B.1 <u>Public Hearing on Revenue Sources and Potential Property Tax</u> <u>Increase and Potential EMS Levy Decrease</u>

STAFF REPORT

Per RCW 84.55.120 the City is required each year to hold a public hearing to consider the next year's Revenue Sources (2021) and determine whether a property tax increase and/or EMS Levy increase is necessary.

The City Council then deliberates on whether to increase the regular property tax levy and/or the EMS levy. By Washington State Law, without a public vote, the City may only collect an additional one percent (1%) over what was collected the previous year for both the property tax and the EMS levy. There is an additional factor that the City has not been faced with in years past: Municipalities that belong to a fire district and/or library district may only collect (again, without a public vote) a maximum of \$3.60 per \$1,000 of assessed value from its property owners in taxes (property tax, EMS Levy, Library Levy and Fire District Levy). For 2021, the City's property owners will pay the following amounts per \$1,000 of assessed value:

Spokane County Fire District 3: \$1.50 Spokane County Library District: \$0.50 EMS Levy (If approved by Council): \$0.00 Subtotal: \$2.00

> \$3.60 (Maximum) -\$2.00 (from above)

2021 City Property Tax Rate: \$1.60

The City's 2020 Assessed Value was \$321,673,550 and its Property Tax Rate was \$1.80 per \$1,000 of assessed value for a property tax revenue of \$579,406.40.

The City's 2020 EMS Levy revenue was \$145,580.

The City's 2021 Assessed Value is \$362,149,589 and its maximum Property Tax Rate is \$1.60 for a projected property tax revenue of \$579,439.34 which is an increase of \$32.94 (0.006%) over the previous year.

For the 2021 EMS Levy, due to being annexed into SCFD3 the amount to be collected should be set at \$0.00.
