**4.A.4(a.)**Resolution 532; Authorizing Investment of City of Medical Lake
Monies in the Local Government Investment Pool

**BACKGROUND:** This resolution is required because of the City switching their LGIP account from Umpqua Bank to First Interstate Bank. The current resolution approved in 2014 names former Finance Director Jennifer Hough as the "authorized individual" and needs updated. The authorized individual in the proposed resolution are the Finance Director and City Administrator, and named by title only.

From First Interstate Bank: "Per the current resolution on file, the only person allowed to sign the form for making changes on the account is Jennifer Hough. If Jennifer is no longer there then we must do an updated resolution before I can make the bank account changes. I have attached the resolution for you.

I want to point out that in the resolution we do not require a name and title any more. You can list just a title and more than one title can be listed if you wish.

Once I get the resolution back then I can make the updates."
