RE: Emergency Declaration – Gray Fire

Dear City Staff,

I hope this letter finds you in good health and spirits. It is with a heavy heart that I write to you today to address the pressing and alarming situation that our beloved City of Medical Lake is facing. As you are undoubtedly aware, a devastating wildfire has rapidly spread throughout our region, causing significant destruction and posing an imminent threat to our community, its residents, and the environment.

Given the severity and potential consequences of this wildfire, and in accordance with the established protocols and procedures, I am left with no choice but to declare a state of emergency for the City of Medical Lake. This declaration will provide our city with the necessary resources, tools, and authority to effectively respond to and manage this crisis in a coordinated and efficient manner.

The wildfire, which began August 18, 2023 and has since escalated due to unfavorable weather conditions and challenging terrain, has led to the evacuation of numerous residential areas within our city's boundaries. The safety and well-being of our residents remain our top priority, and it is imperative that we take all necessary actions to ensure their protection.

I have been in close contact with local and regional emergency response agencies, as well as state and federal authorities, to secure additional resources such as firefighting personnel, equipment, and air support to aid in our firefighting and containment efforts. Our emergency operations center has been activated, and we are closely monitoring the situation's developments to make informed decisions for the safety of our community.

Let us stand united as a community and face this challenge with resilience, courage, and compassion. Together, we will overcome this adversity and work tirelessly to restore the City of Medical Lake to its rightful state of tranquility and prosperity.

CITY OF MEDICAL LAKE SPOKANE COUNTY, WASHINGTON RESOLUTION NO. 23-622

A RESOLUTION OF THE CITY OF MEDICAL LAKE DECLARING A STATE OF EMERGENCY AND WAIVING PROCUREMENT REQUIREMENTS PURSUANT TO SECTION 3A OF THE CITY OF MEDICAL LAKE PROCUREMENT POLICIES

WHEREAS, the City of Medical Lake ("City") and surrounding area experienced a life-threatening wildfire ("Gray Road Fire") on August 18, 2023, which caused severe damage to City property and land; and

WHEREAS, the Mayor wrote a letter to City Staff on August 19, 2023, declaring a state of emergency as a result of the Gray Road Fire and authorizing the emergency use of resources to combat the fires and subsequently restore the City; and

WHEREAS, Section 3A of the City's procurement policies state that procurement requirements may be waived in the event of an emergency; and

WHEREAS, the City Council finds that an emergency situation does exist and that it is appropriate to waive the aforementioned procurement requirements in relation to any purchases that occur as a result of the Gray Fire,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MEDICAL LAKE, WASHINGTON, pursuant to Section 3A of the City's Procurement Policy, a State of Emergency does exist for the above stated reasons to waive procurement requirements for purchases in response to the damages caused by the Gray Fires.
