Planning Commission Meeting October 26, 2023, Minutes

1) CALL TO ORDER, PLEDGE OF ALLEGIANCE, AND ROLL CALL

a) Commissioner Hudson called the meeting to order at 5:30 pm, led the Pledge of Allegiance, and conducted roll call. All commissioners were present in person.

2) ADDITIONS TO AGENDA

- Motion to add agenda item and approve agenda made by commissioner Mayulianos, seconded by commissioner Munson, carried 5-0.

3) APPROVAL OF MINUTES

- a) September 28, 2023, minutes.
 - i) Motion to approve made by commissioner Mayulianos, seconded by commissioner Mark, carried 5-0.

4) INTERESTED CITIZENS: AUDIENCE REQUESTS AND COMMENTS

5) STAFF REPORTS

- a) Elisa Rodriguez, City Planner Official Zoning Map approved by City Council. It will be put on website soon and will have printed copies to hang in office(s).
- b) Commissioner Hudson asked for Martin Street update. Mrs. Rodriguez shared an update. Silt fence will be extended to paved street. Trees can be removed without a permit. No more work will be done until spring.

- b) Revisiting Shipping Container Ordinance
 - i) Elisa Rodriguez reviewed the timeline and shared that the reason for revisiting the discussion was to share new language with the commission and workshop it. Gave a presentation. See Attachment A.
 - ii) No decisions requested tonight but wants discussion. Originally the problem was with aesthetics. Asked if commissioners felt that the new language addressed those concerns. Commissioner Hudson asked for clarification as to why City Council sent it back to the Planning Commission. Mrs. Rodriguez explained that it was to review language that they had not seen after the council public hearings.

- iii) Commissioner Mayulianos asked what would happen to the citizens that currently have shipping containers if the ordinance is denied. Answer is that Code Enforcement would send letter and they'd have to remove the container. Code enforcement officer would enforce.
- iv) Commissioner Jorgenson feels that there is no way to keep the containers from looking unappealing.
- v) Commissioner Mayulianos expressed concern that not one council member asked the Planning Commission why they voted no. Mrs. Rodriguez explained that the commission information was presented to the council in the staff report and in the minutes. Mr. Weathers also reiterated that council had been given all the information and considered it carefully.
- vi) Commission gave the direction that the new language does not address the issue. Mrs. Rodriguez will draft a staff report and bring back.
