### Planning Commission Meeting December 19, 2024 Minutes

#### 1) CALL TO ORDER, PLEDGE OF ALLEGIANCE, AND ROLL CALL

a) Commissioner Hudson called the meeting to order at 5:30 pm, led the Pledge of Allegiance, and conducted roll call. Commissioner Mark was present on Zoom with all other Commissioners present in person.

#### 2) ADDITIONS TO AGENDA

a) No additions. Motion to approve as written made by Commissioner Mayulianos, seconded by Commissioner Munson, carried 5-0.

#### 3) INTERESTED CITIZENS: AUDIENCE REQUESTS AND COMMENTS

#### 4) APPROVAL OF MINUTES – November 21, 2024

a) Motion to approve made by Commissioner Mayulianos, seconded by Commissioner Mark, carried 5-0.

a) Elisa Rodriguez, City Planner - Department of Commerce reviewed MLMC change and it is in compliance. A public workshop will be held in January regarding Hazard Mitigation Plan representation and input. This is not a public hearing, it is to gather input from the Commission and other citizens.
