# A RESOLUTION OF THE CITY OF MEDICAL LAKE CONFIRMING THE APPOINTMENT OF RICHARD MOUNT AS MUNICIPAL COURT JUDGE.

WHEREAS, the Interlocal Cooperation Agreement, RCW 39.34, authorizes public agencies to contract with one another to perform any act that each is independently authorized to perform; and

WHEREAS, on or around July 21, 2025, the City of Medical Lake and City of Airway Heights entered in that certain Interlocal Agreement Between the City of Airway Heights and the City of Medical Lake for the Provision of Municipal Court Services and Facilities ("ILA"), and

WHEREAS, pursuant to the ILA, the City of Medical Lake City Council is to confirm the appointment of a municipal court judge that is to preside over and hear Medical Lake municipal cases.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MEDICAL LAKE, WASHINGTON, as follows:

- **Section 1**. <u>Confirm Appointment</u>. The City Council hereby confirms the appointment of Richard Mount as Municipal Court Judge pursuant to the ILA.
- **Section 2**. <u>Severability</u>. If any section, sentence, clause, or phrase of this Resolution should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Resolution.
- **Section 3**. <u>Effective Date</u>. This Resolution shall be effective immediately upon passage by the City of Medical Lake City Council.
